The Ethics Manager plays a vital role in upholding the integrity and spiritual principles of our organization. This contractor engagement supports CSL in addressing and reviewing reported ethics concerns and violations in alignment with CSL's values and policies. The Ethics Manager provides guidance, support, and clarity to individuals and communities navigating ethical questions or concerns.

Scope of Services

- Receive and review reports of ethics concerns or violations.
- Conduct reviews and investigations with objectivity, care, and professionalism.
- Provide clear, values-based guidance to involved parties.
- Collaborate with the CSL Ethics Committee and leadership.
- Maintain confidentiality and accurate documentation in all cases.
- Ensure services align with CSL's ethics policies and procedures.

Qualifications

- Ordained Minister of Religious Science, active, licensed, and in good standing (required).
- Degree in Ethics, Moral Philosophy, or a related field. (required)
- Experience in mediation, conflict resolution, or investigative processes (preferred).
- Demonstrated commitment to ethical leadership and spiritual integrity.
- Ability to communicate complex ethical principles with compassion and clarity.

In this role, you are expected to:

- Exercise impartiality and objectivity when discussing matters of concern within the organization. Maintain the highest level of privacy and confidentiality, ensuring that confidential information remains securely within the organization.

- Uphold professional boundaries and ethical conduct in all interactions, fostering a culture of trust and integrity within the organization.
